PUBLISHING AGREEMENT

The agreement

Forum Doktor Poltekkes Seluruh Indonesia hereby authorises KnE Publishing Services to include the proceedings of its conference; **First International Conference on Health Profession (1st ICHP)**, on the KnE Publishing Services website within the KnE Conference Proceedings Series with the objective of providing a stable online version of the proceedings and raising its online visibility

1. Ownership

1.1. Ownership of the Proceedings

- 1.1.1. The authors shall retain copyright ownership of their content, but license the organisers and KnE Publishing Services to publish their article on the KnE Publishing website under a CC BY open access license
- 1.1.2. KnE Publishing Services shall retain copyright ownership of any files created through the hosting of the proceedings
- 1.1.3. KnE Publishing Services shall retain exclusive ownership of the Proceedings Series name and identity but shall give full acknowledgement of the conference and the Organisers and provide online links to their website as directed

2. Responsibilities of Forum Doktor Poltekkes Seluruh Indonesia shall include

- 2.1. To warrant that Forum Doktor Poltekkes Seluruh Indonesia has full power and authority to enter into this agreement and authorises Knowledge E to publish the proceedings content as supplied from Forum Doktor Poltekkes Seluruh Indonesia to Knowledge E
- 2.2. To warrant that the content has been reviewed and deemed suitable for publication
- 2.3. To warrant that the authors have agreed that their work shall be published under a Creative Commons Open Access Attribution license
- 2.4. To warrant that the content provided contains nothing libelous, illegal or fraudulent, and to indemnify Knowledge E against any claims, damages, liabilities costs and expenses that may arise out of any breach of Forum Doktor Poltekkes Seluruh Indonesia responsibilities
- 2.5. To respond to the revised GallyProof version within two weeks (max) from the date of receiving the updated GallyProof version

3. Responsibilities of Knowledge E shall include

- 3.1. To convert and upload the conference proceedings on the Knowledge E website in a timely manner
- 3.2. To remove or refuse to publish any content from the site that Knowledge E deems to be libelous, fraudulent or otherwise illegal
- 3.3. To ensure that the Conference details and any contact details as provided by Forum Doktor Poltekkes Seluruh Indonesia are correctly represented on the website
- 3.4. To retain and manage the website to provide on-going access and to archive the content within secure systems
- 3.5. To ensure that the Knowledge E website meets international standards for technical quality, including registering the proceedings articles with relevant indexes
- 3.6. To subject all manuscripts to Crossref Similarity Check, that uses iThenticate technology and notify the conference organiser of any suspected plagiarism
- 3.7. To perform one-round copy editing on all manuscripts and send the final version (galley proof) to the conference organiser for final approval before publishing
- 3.8. To register every article in the international Crossref database that generates its own unique identifier (DOI)
- 3.9. To submit the conference proceedings for evaluation and upon acceptance, for indexing to all major databases as well as discovery services and other global repositories
- 3.10. To accept any minor changes in the published articles only within one week from the publication date (changes such as, updating the corresponding emails, fixing section head)
- 3.11. To warrant that Knowledge E has full power and authority to enter into this agreement and perform its obligations

4. Financial agreement

4.1. Forum Doktor Poltekkes Seluruh Indonesia agrees to pay Knowledge E USD\$11,000 as scheduled below:

4.1.1. Forum Doktor Poltekkes Seluruh Indonesia agrees to pay Knowledge E 100% of the agreed amount upon signature of this agreement and receipt of the corresponding invoice
